3. Be of outstanding quality, high moral character, integrity, and held in high esteem, by his/her colleagues.
4. Have contributed significantly to the development of the Community, the Albany State University National Alumni Association, Inc. and/or Albany State University.

All nominations must be made on an official Hall of Fame Nomination Form. If additional forms are needed, please make a copy of the official form.

Complete the form in its entirety. Consideration will only be given to nominees with completed forms. **NO EXCEPTIONS.**

If additional space is needed to complete the nomination form, please type or print on a separate page (please reference appropriate questions). Limit nomination to one nominee per category per form. Submit a separate form for each nomination made.

The Alumni Hall of Fame Selection Committee will make its recommendation based solely on information provided on/with the Nomination Form. Please provide detailed information. Resumes and biographical sketches can be submitted as supporting documentation but will not be considered as an official nomination document. **All information of recognition(s) and accomplishments, (at least 10 overall) must be supported by copies of those achievements as well as degrees and other awards. Statements of events without supporting documentation are not sufficient.**

All Nomination Forms must be signed and dated.
